Dear Madam,

I refer to your letter 19/04/2013 to Mrs. Barnes enclosing a copy letter dated 14/6/2012 detailing estimated tax administrative and punitive demands totaling \$33,095.10 and the proviso of an added 75% penalty for non settlement within the stipulated time frame.

I wish to advise you that even though you are working for an organization you are personally responsible for any outcomes resulting from your personally 'signed' DEMAND NOTICE because, not only is it an intrusion into the life of another person thereby disturbing their peace and causing mental and emotional trauma, which is in contravention of the 'Standard' required by the Constitution of the land, but it is also a contravention of God's Command:

"Go your way in peace & love one another & be merciful, compassionate & be forgiving & do NOT disturb the peace of the land" and,

In ANY case 'our' client Mrs. Barnes has in the past advised, and now again advises you, that she is NOT a Person liable to be TAXED due to her 'belief, her conscience and her religious ideology' that being the ideology of absolute pacifism, and this belief is totally CONTRA to your own ideology and,

She <u>has IMMUNITY</u> from taxation and persecution within the Freedom of Religion Clause of the land and, ONLY if you and your 'organization' <u>has</u> and 'shows' <u>her</u> a High Court ruling 'nullifying' the "Freedom of Religion" clause of the Constitution will she even 'consider' your demands as such. The reference for her understanding of the 'immunity clause' is set out below:

Commonwealth of Australia Constitution Act (9th July 1900) section 116

"The Commonwealth shall not make any <u>law for establishing any religion</u>, or for <u>imposing any religious observance</u>, or for <u>prohibiting the free exercise of any</u> religion, and - - -

Constitution Act 1934 (Tas)

This document includes a <u>legal guarantee of the religious liberty</u> and equality of Tasmanians. Every citizen <u>is guaranteed freedom of conscience and the free exercise of religion</u> under Section 46(1) of this Act.

Part V - General provisions Religious freedom

- 46. (1) Freedom of conscience and the <u>free profession and practice of religion</u> are, subject to public order and morality, <u>guaranteed to every citizen</u>. -
- (2) No person shall be subject to any disability, or be required to take any oath on account of his religion or religious belief -

Note: Australia's own Macquarie dictionary – page 835 (Compact version)

<u>Religion</u> = - - - - the quest for the values of the ideal life - - - the ideal, the <u>practices</u> for attaining the values of the ideal, - - -

A system of belief in the worship of a supernatural power or God' or the recognition by man of a superhuman power entitled to obedience, reverence, and worship.

Religious = - - - - scrupulously faithful, pious, devotion - - -

This means that ones 'religion' is not any named 'Church' organisation but it is the <u>policy</u> of ones daily <u>code of conduct</u> in their interaction with other children of God.

Please try and understand that legislation may very well delegate instructions TO Taxation officers such as yourself, but it is YOU the <u>individual</u> who takes it upon <u>yourself</u> to instigate an ACTION against a member of the community <u>for the sole purpose of extortion, impoverishment, loss or injury enforced via some form of punishment.</u>

If looked at factually your 'action' is in fact an unfriendly, unkind and 'injurious' ACTIVITY which in itself <u>is</u> in contravention of the Command of God to <u>be</u> always peaceful, loving, kind and merciful.

Further it is <u>also</u> an <u>ILLEGAL</u> activity within the precepts of the Constitution of Tasmania & Australia and thus a <u>TREASONABLE</u> activity against a *peaceful* person who has NO 'agreement' with you or your 'office' stating that she 'agrees' to your 'enforced policy' and ideological stance. (Religious belief)

Furthermore, within the authority granted by Tasmanian and Australian Constitutions, any subsequent RULING or ACT which conflicts with the 'Freedom of Religion' Clause is 'overruled' and nullified and, - - -

For you to pursue your claims <u>is</u> Treason and Anarchy, and I can assure you that any claim which you personally or, using any other agency such as 'Baycorp' or MPES, will be deemed a 'Criminal Act' because the reality is that in fact you are imposing your religious ideology upon another.

Being your belief in the superiority of ATO rules above God's Command and the Australian Constitution. For your information I attach relevant documents to assist you and all readers.

You also need to understand that if you use a magistrates Court 'finding' to 'collude' with any Bank in order to get them to transfer funds to the ATO from Mrs. Barnes' bank account, that this <u>also</u> is a <u>criminal</u> and <u>treasonable</u> ACT having grave consequences indeed to all 'complicit' and that would include the magistrate.

I reiterate, you <u>are</u> an individual operating <u>on behalf of yourself</u> due to the <u>fact</u> that you TAKE a 'wage' to <u>be</u> a 'combatant' taking up 'ARMS' against a fellow citizen <u>for and on behalf of</u> a <u>RULE</u> or <u>Rulings</u> in a TEXT book, a text book which you <u>believe</u> gives you the <u>RIGHT</u> and <u>JUSTIFICATION</u> to so do.

Further I ADD; you the <u>individual</u> cannot hide behind the 'facade' of the words 'The Government' being solely the <u>name</u> of an <u>institution</u> of man.

I reiterate, when you send out a letter of demand and that letter contains a further 'threat' of 'added' loss to your VICTIM for NON conformity, as for example that there may be a 75% increase in penalties if your threat to comply is ignored, you are in FACT taking UP a cudgel against them as you disturb their peace, being their mental and emotional state which can and often does cause anxiety, panic, distress etc., at the demand and 'THREAT of great LOSS' to them.

You need to understand that your PRIMARY DUTY to THEM and yourself is to <u>ensure</u> the <u>LEGALITY</u> or otherwise of your 'move' and action and interaction because, -

IF by your own 'mandate' within the rules of the 'establishment' you SERVE it is FOUND that you are EXCEEDING the mandate, then it is an ACT of ANARCHY and TREASON which is so proven by my pen within this 'paper' and the attached Baycorp 1 and 2 documents and, - - -

It is my duty to my 'client,' you <u>and</u> God to advise you of such and to warn you of your already 'accrued' Karmic dues and, IF you 'proceed' against Mrs. Barnes then you <u>are</u> a seriously 'mentally disturbed' person in NEED of good counsel.

The Legislative 'Ministers' of your institutionalised RELIGION <u>have</u> the false belief that they can totally ignore the rulings of the Constitutional Authority granted unto them as

evidenced by the fact that they raise up edict after edict enabling <u>them</u> to steal more and more wealth from THE PEOPLE.

# Commonwealth of Australia Constitution Act (9th July 1900) section 116

"The Commonwealth shall not make any law for establishing any religion, or for imposing any religious observance, or for prohibiting the free exercise of any religion,

Politicians need to ALSO understand the below line in RED:

# Commonwealth of Australia Constitution Act (9th July 1900) section 116

"The Commonwealth shall not make any law <u>for establishing any religion</u>, or for <u>imposing any</u> religious observance, or for prohibiting the free exercise of any religion, and - - -

I state this because in FACT any imposing 'code of conduct' demanded by political edicts IS the 'establishing' of a religious code of conduct DOCTRINE in contravention of the above PRIMARY Act 'clause.'

I add: Within the Australian Criminal code it states:

# 270.3 Slavery offences

- (1) A person who, whether within or outside Australia, intentionally:
- (a) possesses a slave or exercises over a slave any of the other <u>powers attaching to the right of ownership</u>: Penalty: Imprisonment for 25 years.

It needs to be UNDERSTOOD that any person or 'organisation' such as one named 'The government' which uses the back up of armed men to ENFORCE their demands upon others <u>are</u> ASSUMING their 'Right of ownership' over said 'others' and <u>are</u> using and 'treating' them as SLAVES and 'subjecting' them to ongoing SERVITUDE.

#### Servitude

- a. A state of subjection to an owner or master.
- b. Lack of personal freedom, as to act as one.

It is quite obvious that 'officialdom' BEING THE RULES in a book imply 'right of ownership of everyone' on the land and subjects them to ongoing SERVITUDE.

The word 'Tax' is given in the dictionary as meaning:

- 1 (a): A compulsory monetary contribution demanded by a government for ITS support.
- 1 (b): To lay a burden upon someone.

It needs to be seen and understood that there is a 'misquote' clarification needed because in 1 – (a) above, - - - the <u>words</u> <demanded by a government need to be replaced by the <u>words</u> <demanded by a <u>person</u> working for a government institution>

For in REALITY, the tax burden imposed and extorted using the 'back up' of armed men is related directly to the greed, pride, vanity and arrogance of THE ONE who is 'in power' at the time and <u>personally</u> makes the ever increasing 'taxing' demands upon everyone on the land.

The word 'Slave' is given as:

- 2 (a): One who is the 'property of' and wholly subject to another.
- 2 (b): Who works 'for' and is the 'prisoner' of the other.
- 2 (c): One who works under duress and without payment.
- 2 (d): One who is under total domination of another.

Slave master: One who is a hard task master.

Once IN 'power' he then 'invokes' a GST 'rule' and OPENLY steals 10% from every transaction out of the purses of THE PEOPLE and *impoverishes* them and, - - - as 'Fidel,' his position of authority also uses the back up of *armed forces* as he 'subjugated' everyone in a Dictatorial manner.

When we use either we receive BACK on EQUAL 'measure,' that which we either 'gave' kindly' or 'imposed' punitively. This invisible energy essence of the SOURCE is a "Law unto itself" having infinite intelligence, and its 'return' to us CANNOT be controlled by 'us.'

It <u>is</u> ones personal 'choice' to <u>be</u> THE **LIGHT** or THE **DARK** in action.

# **Summary**
